Shenvalee Golf Resort Code of Conduct

Members, Stockholders, Motel Guests, and Visitors – Code of Conduct

Shenvalee Golf Resort deems that upon payment of membership, greens fees/tournament fees, or golf package fees, all members, visitors (a visitor is considered a non-member/stockholder or non-motel guest), and motel guests have given their consent to abide by both the restrictions and penalties imposed by this Code of Conduct.

The intention of this Code of Conduct is to establish clear and acceptable behavior expectations for Shenvalee Golf Resort's members, stockholders, visitors, and motel guests. It is not intended to restrict the rights of anyone, but rather to ensure that everyone can expect to be treated with respect while enjoying their time at Shenvalee Golf Resort.

All members, stockholders, visitors, and motel guests will:

- Conduct themselves in a sportsmanlike and respectful manner
- Respect the rights of all other members, visitors, motel guests, staff, and Directors
- Not engage in any form of discrimination, harassment, or bullying
- Respect the golf course, facilities, and all other Shenvalee Golf Resort property
- Not approach other members, visitors, motel guests, staff, or Directors with abusive conduct, threatening language, or violent behavior
- Abide by all local and national laws and regulations
- Play golf by the rules as put forth by the [USGA](#)* (United States Golf Association)
- Follow all course rules and guidelines.
- Not bring pets on the golf course (this excludes service dogs – see [ADA service animal guidelines](#)*)
- Report any unusual or inappropriate behavior to Shenvalee Golf Resort Management
- Not consume alcoholic beverages on Shenvalee Golf Resort property which were not purchased from the Resort as per Virginia ABC Laws

Interaction with Staff, Management, and Directors

- All members, stockholders, visitors, and motel guests must understand that:
 - They have no authority to instruct staff on duties or job performance
 - Management is responsible for instructing staff in performance of their duties
 - They may make suggestions to Management and Directors regarding operation of Shenvalee Golf Resort for the betterment of the Resort
 - They cannot discipline or disrespect staff members
 - If a member, stockholder, visitor, or motel guest is viewed by a staff member as having over-consumed alcohol, they will be refused bar service and appropriate actions will be taken as per Virginia ABC laws

Discipline for violations to the Shenvalee Golf Resort Code of Conduct

- Shenvalee Golf Resort Management and Directors have the authority to enforce the Code of Conduct with any members, stockholders, visitors, and motel guests who are in violation.
- Members/Stockholders: This may include suspension of rights and privileges of the offending member and/or termination of membership without refund, up to a temporary or complete ban from the property.
- Visitors: This may include a temporary or complete ban from the property.
- Motel Guests: This may include immediate expulsion from the property without a refund, up to a temporary or complete ban from the property.
